Exclusion of liability:

1. Liability for contents

The content of our website was created with the greatest possible care. However, we do not guarantee that this content is correct, complete, up to date or pleasing. According to § 7 Abs. 1 TMG we are responsible for the content, even if it has been ordered.

In accordance with §§ 8, 9 and 10 TMG, we are under no obligation to monitor information transmitted or stored by third parties or to investigate circumstances that indicate illegal activities. Not affected by this is our obligation to block or remove information, which stems from general laws.

2. Liability for links
